- A. The bidders are to quote the rate of wages for the Security Personnel as per latest NOTIFICATION No 6100/ LC, Bhubaneswar dated 20.10.2020 of Labour Commissioner, Odisha, Bhubaneswar.
- B. Copy of the Registration Certificate under Private Security Agencies Regulation Act (PSPRA Act 2005) is required in case of the SPA who will provide security personnel.
- C. The Remuneration will be released to the different categories of personnel as per Finance Deptt. circular No-28090/F of 22/09/2017. As such the monthly remuneration for D.E.O. is Rs.8880/-, office Asst. Rs.8750/-, J.E./Agril Extn. Asst. / Accounts Asst. is Rs.16880/-.  
The wages in respect of Security personnel (Armed, Lathi & Trained civilian guard) will be released as per Notification No-6100 dtd.20/10/2020 of Labor Commissioner ODISHA. This amount is exclusive of ESI / EPF dues of employer's share as per Finance Deptt. Circular No-11835 dtd.31.03.2018. Further this rate is subject to revision, if allowed by Finance Deptt. / Co-operation Deptt. / Labour Commissioner.
- D. Annexure - 5 notified earlier is replaced and enclosed herewith.
- E. Annexure- 6 notified earlier i.e. certificate of declaration regarding blacklisting must be furnished by the SPA through Affidavit.
- F. The DTCN including terms and conditions, Technical and financial bid documents and draft Agreement is to be modified accordingly.
