Sub: Extension of cut-off date for the entry of loanee farmers details by the Banks under PMFBY for Kharif - 2019

Sir,

I am directed to invite reference to the subject cited above and to intimate that as per seasonality discipline notified for Kharif – 2019 under PMFBY the cut-off date for electronic remittance of premium along with consolidated declarations to respective Insurance Company and uploading of details of individual farmers in Crop Insurance portal by the Banks was 16.08.2019 in the State of Odisha.

Due to certain changes like aadhar verification of farmers details entered by the Banks and separate entry of each land parcel/ land area for each farmer on the National Crop Insurance Portal (NCIP) by the Banks, reportedly there have been certain issues with the Banks while entering the data of the loanee farmers for Kharif – 2019. Since the data entry process by the Banks is in progress and istaking more time due to some changes as referred above, the Ministry of Agriculture & Farmers Welfare, Govt. of India after careful consideration, have extended the date for portal entry by the Banks upto 16th September, 2019 vide their letter No. 13011/01/2018-Credit-II-Cr-II dated 23rd August 2019 (Copy enclosed).

Your are, therefore, requested to kindly act accordingly for data entry of the farmers details on NCIP in terms of the conditions contained in the enclosed letter of Govt. of India.

Subject: - Extension of cut-off date for the entry of loanee farmers details by the banks under PMFBY/RWBCIS for Kharif-19 -reg

Madam/Sir.

I am directed to refer to the above mentioned subject and to say that owing to certain changes like Aadhaar verification of farmers details entered by the banks and separate entry of each land parcel/land area for each farmer on the National Crop Insurance Portal (NCIP) by the banks, there have been understanding issues with the banks while entering the data of the loanee farmers for Kharif-19. Various requests have been received from the State Governments and the banks for extension of cut off date of portal entry.

- 2. It has also been brought to the notice of this Department that some insurance companies have rejected the applications which have been entered beyond the cut-off date for portal entry by the banks (where the premium was debited and remitted within cut-off date) without consulting Government of India or the concerned State Government. Since the data entry process by banks is in progress and is taking some more time due to certain changes as referred above, it is deemed appropriate to grant one time extension for data entry by the banks on NCIP. It is therefore decided to extend the date for portal entry by the banks upto 16th September, 2019 wherever the date for remittance of premium was upto 15th August, 2019.
- 3. It is also informed that applications rejected (as mentioned in point 2) during this period by any company on the ground of being entered beyond the cut—off date for portal entry shall be revoked by this Department and any refund of this money by the company to the bank due to this reason shall by taken back by the concerned company. The Insurance companies are being advised that, the portal is already having the capability of auto closure of the season and the Ministry keeps a close watch over the entire process including the circumstances and issues encountered by the stakeholders. Therefore it is advised that in future no rejection on this ground shall be carried out by the companies without consulting the State Government and the Central Government until further orders.
