NOTIFICATION

In pursuance of Hon'ble High Court Letter no.- JJC-02/2022/19220/ 6.12.2023 and this Department Notification No.17355, dated 25.11.2019 relating to constitution of additional Juvenile Justice Board of Sambalpur district which shall function at Sadar Sambalpur and in consonance with the provisions contained under section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2015 [hereinafter referred to as "the Act"] read with Rule 3 and Rule 4 of the Odisha Juvenile Justice (Care and Protection of Children) Rules, 2018, the **additional** Juvenile Justice Board in respect of Sambalpur district is hereby **Re-constituted** for exercising the powers and to discharge the duties conferred on such Board in relation to children in conflict with law as prescribed under the Act and the Rules framed thereunder with immediate effect .

2. The appointment of any member of the Board, except the Principal Magistrate, may be terminated after holding an inquiry by the State Government, as stipulated under sub-section (7) of section 4 of the Act, if she/he —

(i) has been found guilty of misuse of power vested under this Act; or

(ii) fails to attend the proceedings of the Board consecutively for three months

without any valid reason; or

(iii) fails to attend less than three-fourths of the sittings in a year; or

(iv) becomes ineligible under sub-section (4) of section 4 of the Act during his


term as a member.

3. The Board shall function as a Bench and shall have the powers conferred by the Code of Criminal Procedure, 1973 (2 of 1974) on a Judicial Magistrate of First Class.

4. The Board shall meet at such times and shall observe such rules in regard to the transaction of business at its meetings, as may be prescribed.

5. This Notification is in supersession of all previous Notifications/ Office Orders relating to the constitution of Additional Juvenile Justice Board in respect of the above mentioned district.




